Climbing Escalade Canada (CEC) is seeking qualified candidates to act as officials at the 2018 Youth and Open National Championships. These positions will report directly to the CEC Board and will be responsible for ensuring that the competitions follow all CEC Rules and Regulations.

DEADLINE: December 21st, 2017

The positions are as follows:

Head Route Setter

The successful candidate will be appointed from the list of approved route setters by the CEC Board with input from the host gym. The Head Route Setter will be responsible for coordinating the assistant route setters and for designing the setting plan. The Head Route Setter will work directly with the competition organizers to work out logistics and the setting schedule. The Head Route Setter will have the final say on all problems or routes set for the competition to ensure that they comply with regulations and are safe for the competitors to climb. The Head Route Setter is to be present for all competition rounds to deal with technical incidents, cleaning breaks and appeals.

Qualifications –

- Head Route Setter at a minimum of 2 Provincial Championships
- Apprentice Route Setter at a minimum of 1 National Championships
- Current member of the CEC approved route setter list
- Extensive knowledge of the field of athletes and their abilities
- Works well in a team work environment
- Able to provide direction to the apprentice route setters
- Possesses a full understanding of the CEC Rules and Regulations

This position will be compensated by the host gym, with wages to be negotiated directly with the competition organizer.

Jury President

This position will be appointed by the CEC Board. The Jury President (JP) will be responsible for the running of the competition and the field of play areas during the competition. The JP will work with the CEC Judge to ensure that the route judges are properly trained. Working directly with the CEC Technical Delegate, the JP will manage all aspects of the competition, including ISO management, transition and staging zones, technical incidents (creating the gap). The JP will be responsible for collecting all official and unofficial appeals and with processing appeals along with the CEC Judge and CEC Technical Delegate. The JP shall also ensure fair play for all athletes for the duration of the event. The JP will also have final approval of the competition schedule, running orders and results. With the assistance of the CEC Technical Delegate, the JP will conduct all technical meetings.

Qualifications –

- Jury President at a minimum of 2 Provincial Championships
- CEC Judge at a minimum of 1 National Championships
- Currently on the CEC approved Judges list
- Extensive knowledge of competition procedures
- Works well in a team environment
- Able to provide direction to the CEC Judge and route judges
- Possesses a full understanding of the CEC Rules and Regulations

This is a volunteer position, with travel expenses to be provided.

CEC Technical Delegate

This position will be appointed by the CEC Board, with the successful applicant acting as the direct liaison to the CEC Board. The CEC Technical Delegate (TD) is responsible for ensuring that the competition organizer follows all CEC Rules and Regulations. The TD is to be in contact with the organizer throughout the planning process to answer any questions that may arise. The TD will approve the design and set up of the field of play, including the location of all competition zones and spectator zones. Working with the JP, the TD will ensure the running of the competition takes place in a safe manner and is fair to all competitors. The TD will be a part of the Jury for all official appeals.

Qualifications –

- Technical delegate at a minimum of 2 Provincial Championships
- PSO recommendation
- Currently on the CEC approved TD list
- Possesses extensive knowledge of competition procedures
- Has organized a Provincial or National level event or has been a part of an organizing committee
- Works well in a team environment
- Provincial level Judge
- Possesses a full understanding of the CEC Rules and Regulations

This is a volunteer position, with travel expenses to be provided.

CEC Judge

This position is appointed by the CEC Board with input from the host gym. The CEC Judge will work directly with the JP and will be responsible for supervising the route judges. The CEC Judge will assign the route judges and will be responsible for any disciplinary issues related to the route judges. During the competition, the CEC Judge will be responsible for the competition area. This includes the movement of the athletes, the accuracy of judging, and ensuring the safety of the athletes while in the competition zone. The CEC Judge will also be responsible for all unofficial appeals and video reviews.

Qualifications –

- Jury President at a minimum of 1 Provincial Championships
- Currently on the CEC approved Judges list
- Works well in a team environment
- Able to provide direction to the route judges
- Possesses a full understanding of the CEC Rules and Regulations
- PSO recommendation
